Quarter 1, 2021 - Main Highlights

- Over the first quarter as a whole, the FTSE World Government ex-US Bond Index fell 6.4% in US dollar unhedged terms. In local currency terms the index fell 2.5%, with benchmark international currencies falling 4.0% on average against the US dollar. The strongest performing markets were Norway (-1.5%), Canada (-3.2%) and Israel (-5.3%). Currency was the main driver of outperformance in the case of Norway and Canada, whereas for Israel it was local bond market outperformance. The weakest performing markets were Denmark (-7.6%), Sweden (-7.4%) and Mexico (-7.1%). Currency was the chief detractor in the case of Sweden, whereas for Denmark and Mexico it was local bond market underperformance.
- The Mondrian International Government Fixed Income Fund slightly underperformed the performance of the benchmark index over the first quarter with the Fund down 6.47% against a fall in the FTSE World Government ex-US Index of 6.42%. The modest overweight positions to the Singaporean market and to Mexico detracted from relative performance over the quarter. These positions were broadly offset by the underweight to the weak UK market and the overweight position to the Japanese market, which both added to relative performance over the quarter.
