The returns prior to the inception date of the MSCI EAFE Value Index (December 8, 1997) cannot be provided as data is back-tested data (i.e. calculations of how the index might have performed over that time period had the index existed).

Quarter 3, 2021 - Main Highlights

- International equities were mixed in the third quarter, ending slightly lower after a weak September where investors wrestled with concerns around Fed tapering, ongoing supply chain pressures, rising inflation, and fears of contagion from the Evergrande debt crisis in China.
- In the third quarter, Fund returns lagged index returns despite showing defensiveness in September
 - Country allocation was broadly neutral for relative returns
 - Stock selection in Germany and Hong Kong held back relative returns
 - Relative returns were supported by the overweight position in the strong energy sector
 - Currency allocation added to relative returns
